We shall be on standby for any calls which will need to be encrypted and all meetings held will be confidential

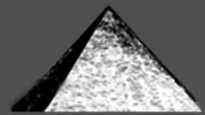

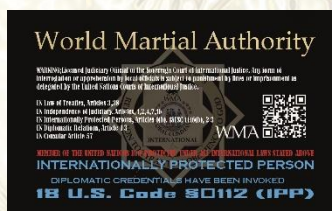
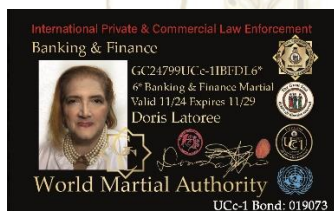
For all the above and the following THEREFORE to strengthen the Constitution, Population and laws of Bolivia to the following:

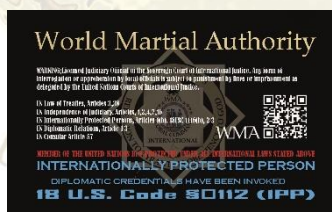
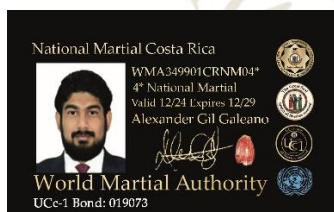
